DEED OF DECLARATION OF TRUST

This deed of trust is made on the 10th day of April 2019 by

- 1) Mr. G.Kaviyarasu, son of Mr.R.Govindasamy, aged about 35 years residing at 1, Merkala Thottam, Murungapalayam, Avinashi Road, Tirupur - 641603

hereinafter called "THE AUTHOR" on the one part and

hereinafter called "**THE TRUSTEE**"

on the other part.

Whereas the author is desirous of setting a trust for the welfare of society and whereas the author has endorsed in favour of and delivered to the Trustees a sum of Rs.1000/- (Rupees one thousand only) to hold the same in Trust for the said author subject to the powers, provisions and scheme hereinafter declared and expressed.

NOW THIS DEED OF TRUST WITNESSES AS FOLLOWS:

1. **TRUST NAME :**

The name of the trust shall be "VICE-CHAIRMAN SUBBURAYA GOUNDER GRK EDUCATIONAL TRUST"

2. **REGISTERED OFFICE :**

At present the **registered office** of the trust shall be situated at **1, Merkala Thottam, Murungapalayam, Avinashi Road, Tirupur - 641603**. It shall be changed according to the convenience of Trustees.

3. **THE PRICIPAL OBJECTS OF THE TRUST ARE :**

- a) to provide all necessary facilities for the education of the poor irrespective of caste, creed or community and for that purpose.
- (1) establish and/or run educational institutions;
 - (2) establish and/or run hostels for the students studying in various institutions;
 - (3) offer assistance to the students pursuing research work in the field of education.
 - (4) establish and/or run institutions for the promotion of fine arts.
 - (5) publish literature of Educational value and arranging seminars and probagate education in all possible ways.
- (b) To afford medical relief to the sick and suffering without any restriction as to caste, community or creed by constructing and/or maintaining hospitals, dispensaries, maternity and children's home etc.,

- (c) To construct and or maintain Libraries, Public Halls for the benefits of the public.
- (d) To contribute to any other existing educational institutions for such purpose or purposes as the Trustees may deem fit without any restriction as to any caste, community or creed, granting scholarships or subsidies to poor students.
- (e) To provide mid-day meal facilities to poor students of any educational institution.
- (f) Any other object of general public utility, not involving the carrying on of any activity of profit, permissible under the provisions of Section 80G of the Income -Tax Act 1961 or any Statutory modification or re-enactment thereof for the time being in force.
- (g) The Income of the Trust shall be applied only to charitable purposes in India.
- (h) Any income arising out of the Trust Properties whether movable or immovable after meeting all the expenses of the Trust shall be utilised for all or any of the aforesaid objectives as the Trustees may decide in future.

4. **THE ANCILLARY OBJECTS OF THE TRUSTS ARE :**

- (a) This trust should follow all the rules, norms and guidelines of tamilnadu trust registration Act.
- (b) This trust should strictly follow all the rules and guidelines of income tax act of trust.
- (c) To draw , make accept, endorse and negotiate cheques, promissory notes, bills of exchange, hundies and other negotiable instruments in pursuance of the objects of the trust.
- (d) To acquire, purchase, hire, exchange, sell or lease any movable or immovable property to further the objectives of the trust.
- (e) To borrow or raise funds either by loan or otherwise against the security of any immovable property of the trust, to further the objects of the trust.
- (f) To raise donations, contributions or grants either from india or abroad from any persons, company, trust or Government.
- (g) To receive, hold and disperse funds to promote the objects of the trust.

- (h) None of the activities of the trust shall result in profit.
- (i) No part of the income of the trust shall be distributed among the trustees or persons mentioned in section 13 (1) (c) of the income tax act 1961 by the way of dividend or profit.
- (j) All the income of the trust shall be utilized only towards the object of the trust.
- (k) To help poor children, physically handicapped and mentally disordered persons.

5. **CONSTITUTION OF THE BOARD OF TRUSTEES:**

- (a) The trust shall be managed by one managing trustee and minimum of 1 trust member and a maximum of 6.

At present the board of trustees shall consist of the following persons

- 1) Mr. G. KAVIYARASU (Managing Trustee)
- 2) Mrs.R.KAVIPRIYA (Trust Member)

- (b) Mr. G. Kaviyarasu shall be the Managing Trustee and shall hold office for life.
- (c) The managing trustee shall be in over-all control of the day affairs of the trust.
- (d) The board may co-opt more trustees subject, to the maximum number of trustees, shall be serve as trustees.

6. **POWERS OF MANGING TRUSTEE**

- (a) The managing trustee is the head of the Trust.
- (b) Managing Trustee shall hold the office for life without retirement.
- (c) Managing trustee shall be in over-all control of the day affairs of the trust.
- (d) Managing trustee is responsible for all legal activities of the trust and he is the complete authority for cheque signatory for bank works.
- (e) The Managing trustee shall determine, from time to time the amount it shall spend on the different aspects of the activities of the trust subject to payment of tax if any.

- (f) The Managing trustee shall have power to invest the Corpus for the income from the Trust Fund at their direction in such investments may be permitted under the Income-Tax law, in force from time to time.
- (g) The Managing Trustee shall open an account or accounts with any scheduled bank or banks and all such bank accounts shall be operated by the Managing Trustee's signatory only.

7. ADDITION AND REMOVAL OF TRUSTEES :

- (a) In case of any vacancy in the Board of Trustees arising on account of death, retirement or resignation the managing trustee has the rights to fill the vacancy. Any trustee if needed can be added to the board only after the approval of managing trustee.
- (b) The managing trustee has all the rights to accept or decline any new trustees application to the trust board without any notice.
- (c) Any trustee may be removed by the managing trustee for the breach of trust code or mis-conduct.
- (d) Any trustee desirous of retiring from the trusteeship shall be entitled to do so after giving one clear calendar month's notice in writing to the managing trustee.

8. VACANYOF THE MANAGING TRUSTEE

- (a) In the event of any vacancy arising in the post of the Managing Trustee by resignation, death or otherwise by medical fitness, the existing trustee shall be the managing trustee thereafter and govern the trust with above said points.

9. POWER OF THE BOARD OF TRUSTEES :

- (a) However the Managing trustee have powers of absolute management of all affairs, activities and business of the trust, the board of trustees will join and help the managing trustee to achieve the aims and smooth running of the trust. The Managing Trustee shall duly carry out all the decisions made by the Board of Trustees, without limiting or in any way restricting the generality of their powers, anyhow the managing trustees decision is the final.

- (b) It shall be lawful for the Board of Trustees to frame rules and regulations for the conduct and management of the Trust.

10. **MEETINGS OF THE BOARD OF TRUSTEES:**

- (a) The trustees shall meet as many times as may be considered expedient.
- (b) However, before the expiry of six months from the end of every financial year the trustees shall meet to adopt the statement of accounts for the financial year shall appoint a Chartered Accountant to Audit the accounts of the Trust.
- (c) The meetings shall be Governed by the Managing Trustee after giving due notice in writing, to all the trustees, of 7 clear days.
- (d) The Managing Trustee shall maintain minutes of all meetings.
- (e) If a Shorter notice is given the Board of Trustees may unanimously ratify the shorter notice.
- (f) The Board shall transact only business that may be specified in the agendas or any other matter that may be brought up with the permission of the chair.
- (g) The Managing Trustees shall preside over all the meetings of the board and in the event of equal votes, he shall have a casting vote.
- (h) Two trustees present shall constitute the quorum for the meeting of the Board of Trustees. If after two adjournments the quorum is not present the members present shall constitute the quorum.
- (i) Unless otherwise provided herein, all decisions shall be carried by a simple majority and in the event of equality of votes the issue shall be decide by the casting vote of Managing Trustee.
- (j) Any resolution in writing circulated to all the Trustees and accepted and signed by a simple majority of the trustees in token of their said acceptance shall be valid and binding on the Board of Trustees as though the said resolution has been passed at a duly convened meeting of the Board of Trustees.
- (k) The Board of Trustees may invite any other person or persons interested in the work of the Trust to attend the meetings of the Board of Trustees, but they shall not be entitled to vote there at on any matter or resolution.

11. **PROPERTY OF THE TRUST :**

- (a) All the properties of the Trust as and when acquired whether movable or immovable shall at all times stand vested in the Trust.
- (b) All funds of the Trust, as and when acquired, shall be invested in such manner as may be approved by Section 13(1) (d) read with section 11(5) of the Income Tax 1961.

10. **FINANCIAL YEAR :**

The Financial year of the trust shall be from the 1st April to the 31st March of the following year and regular accounts shall be maintained in the normal course, accordingly.

11. **ACCOUNTS AND AUDIT:**

- (a) The accounts of the trust shall be regularly maintained and annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statements of account and the Auditor's report thereon shall before Board of Trustees for its approval and adoption within six months from the close of the financial year.
- (b) The Trust shall apply for registration with the Commissioner of Income tax as a Non-profit organization.
- (c) All the bank activities shall be carried out only by managing trustee and he is the only authorised to operate the account activities.

12. **AMENDMENTS:**

This trust shall be irrevocable. Though this Trust shall be irrevocable, the Managing Trustee or the Author of the trust, may subject to the prior approval of the Commissioner of Income-Tax amend any of the clauses contained herein in relation to the Management of the Trust at a duly convened meeting of the Board of Trustees by a resolution passed unanimously of which resolution, at least two week's notices shall have been given to all the Trustees.

No amendment shall be made to the objects of the trust and no amendment shall be repugnant to the provisions of Section 2(15) and Section 11,12,13 and Section 80-G of the Income Tax Act 1961.

13. WINDING UP:

- (a) If the Managing Trustee decides that no useful purpose will be achieved by the continuation of the Trust, it shall be open to the Author to dissolve and wind up the Trust.
- (b) In the event of such dissolution or winding up of the Trust, the assets and properties of the Trust or any part thereof shall not be appropriated by or distributed among the Trustee or the staff of the Trust or their relatives.
- (c) In such event of dissolution or winding up of the Trust, the assets and properties or any valuable part thereof shall be disbursed, transferred and assigned to any other Trust having similar objects and Registered under section 12AA and 80G of Income Tax Act 1961.

14. GENERAL:

- (a) The Trustees shall at all times stand indemnified in respect of any acts of commission or omission by them in respect of matters relating to the Trust.
- (b) The Trust shall be irrevocable.
- (c) At present this trust has no movable or immovable property other than this corpus amount of Rs.1000/-

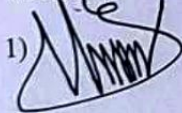

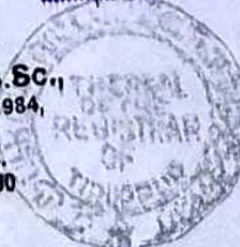
